ACKNOWLEDGEMENTS

Thanks must first be given to the Librarian of St. Paul's Cathedral and the staff of the City of London Guildhall Library whose generous, extended research at an early stage produced key information on George Maitland Stapley. That would not have occurred had they only answered the question I had asked of them.

The Stapley history before 1615 is almost entirely supplied by Brian Saunders of Perth, W.A., the leading researcher into all branches of the Stapley family (ours is one 'clan' of twenty-two). He, in turn, acknowledges his indebtedness to W.H.H. Stapley of Southwater, Sussex, Shirley Stapley of Plymouth, Neville Thomas of New Zealand and Jim Derriman of Morden Surrey. Where possible he has given me details of the primary source but, in the earlier days of family history research, information was more readily accepted on only the word of another researcher. Sometimes this led to exaggerated claims or the introduction of errors. That is true, unfortunately, also of the huge collection of baptisms and marriages compiled by the Church of the Latter Day Saints (The Mormons) which is known as the International Genealogy Index (IGI). When it is the only known source of information, the fact is noted.

There have been two very fertile printed sources for the Strangwayes family, the first being the series of *The Victoria History of England*, county by county. In this huge series, part of each county's history is organised to give the histories of manors and their owners or tenants and can, therefore, yield histories of families at the 'gentry' level. The second is Foster's *Pedigrees of the County Families of England* ¹ from which a detail of the Strangwayes pedigree is included in this book together with the detail from the family hand-written version, mentioned above.

Current descendants of George Maitland and Lucy Jane Stapley have contributed not only the basic, dry 'landmark' dates of their families but also the brief biographies that are included (but not in the 'library editions'). These have been edited only for some degree of uniformity and the elimination of pre-adult information. I thank them all for their patience and the trouble they have taken.

The family has also contributed 'family folklore', all of which has been included. Some of that folklore, as I suspect occurs in all families, makes a good story for which no evidence has been found: some contains a basis of genuine information for which evidence exists. Yet more has strong circumstantial evidence but lacks documentation. The most frequent Stapley stories concern the alleged link to Sir Anthony Stapley, 'the regicide', and to links with the pharmaceutical manufacturer, Allen & Hanburys, now part of the Glaxo Wellcome group. Each of these is discussed in the appropriate section.

One of the pleasures of this investigation has been the interest taken in the story of the Stapley and Strangwayes families: rather than suggest to me a line of further investigation, these contacts have often, like those mentioned above, followed that line themselves and sent me the results.
